### NOW THIS POLICY WITNESSETH:

That subject to the Terms, Exceptions and Conditions contained herein or endorsed or expressed hereon:

### I) LIABILITY TO THIRD PARTIES

- ABILITY OF INIDO PARTIES

Notice shall also be given in writing to the Company immediately the insured shall have knowledge of any impending Prosecution Inquest or Fatal Inquiry in respect of any accident which may give rise to a claim under this Policy.

  2. No admission, offer, promise, payment, or indemnity shall be made or given by or on behalf of the insured without the written consent of the Company which shall be entitled if it so desires to take over and conduct in the name of the insured for its own benefit any claim for indemnity and assistance as the Company any require. If the Company shall make any payment in settlement of any claim and sustinance as the Company any require.
