

Must ensure that One Chemical extinguisher and six fire buckets for each 3000 sq. ft floor area are made available.
- 2. Warranted that No accumulation of large stock at one place is allowed. There should be a gap of 20 feet between two heaps of cotton.
- 3. Warranted there is no storage of stocks in the normal passage areas.
- 4. Warranted that battery operated equipments like forklifts etc shall be used for loading/unloading operations.
