

A sufficient quantity of water shall always be kept in the tank connected with the hydrant service and at least eight men trained in the operation of fire fighting appliances shall be available on the premises round the clock. Must ensure that One Chemical extinguisher and six fire buckets for each 3000 sq. ft floor area are made available.

- 2. Warranted that No accumulation of large stock at one place is allowed. There should be a gap of 20 feet between two heaps of cotton.
- 3. Warranted there is no storage of stocks in the normal passage areas.
- 4. Warranted that battery operated equipments like forklifts etc shall be used for loading/unloading operations.
- 5. Warranted proper ventilation in the gowns is maintained to prevent dampness and moisture.
- 6. Warranted electrical wiring and equipment are installed as per latest industrial type.
