- 2.Warranted that No accumulation of large stock at one place is allowed. There should be a gap of 20 feet between two heaps of cotton.
- 3.Warranted there is no storage of stocks in the normal passage areas.
- 4.Warranted that battery operated equipments like forklifts etc shall be used for loading/unloading operations.
- 5.Warranted proper ventilation in the godowns is maintained to prevent dampness and moisture.
- 6.Warranted electrical wiring and equipment are installed as per latest industrial type.
